### **PRESIDENT'S LETTER**

A lot has been happening affecting our neighborhood since our last meeting. Our board has been actively working with County staff and other civic associations on a wide range of issues, including staffing for a study of whether to adopt further restrictions on lot coverage (or "footprint"), height, and setbacks for residential properties (both single family and "missing middle"); addressing traffic and speeding issues on key roads in our neighborhood; completing the design of the traffic circle at Military Road and Nelly Custis Drive prior to soliciting bids for that project, which has both support and criticism from Donaldson Run Civic Association (DRCA) members; monitoring the progress of Donaldson Run stream restoration projects; supporting our congressional delegation's effort to limit additional long distance flights over our neighborhood into Reagan National Airport; and identifying ways we might be able to protect more of the diminishing tree canopy within the neighborhood.

I hope you will make a special effort to attend our last meeting before summer vacation, which will be on **Wednesday**, **June 12**, again at Taylor School, beginning at 7:30 p.m. with a social half hour at 7:00. We will be experimenting this time by also introducing the option of virtual participation by Zoom for those who cannot attend in person. Please see the instructions on page 2 of this newsletter for how to attend virtually.

After conducting our biennial elections (see p. 3 for the slate proposed by our Nominating Committee), we will be hearing a report from our state delegate and senator, Patrick Hope and Barbara Favola, about this year's recently completed recent General Assembly session in Richmond. We have periodically invited our state delegation to address you, and this is the first time we have done so since redistricting put us into Patrick's district. In а of increasing concerns light about tree preservation, we will then hear from Vincent **Verweij**, the County's Urban Forest Manager.

**Patrick Hope** has served in the House of Delegates since 2010. He is a lawyer in the health care field, now chairs the House courts committee, and serves on the health and human services and public safety committees. This year, we and others worked with him on a number of tree preservation bills. He also introduced a bill, tabled until next year, to provide Arlington County with the authority (as in Fairfax County) to elect a County Board chair, and members from specific geographic districts in the County (rather than at large). Patrick was previously the first president of the Buckingham Community Civic Association.

**Barbara Favola** has been a state senator since 2012. She once served as senior advisor at the federal Department of Health and Human Services, was a County Board member for 14 years, and now is chair of the state senate's rehabilitation and social services committee. Her particular focus has included women's health and disability issues. She also serves on Senate committees with jurisdiction over conservation and natural resources, education and health, and finance and appropriations.

Vincent Verweij has responsibility for County programs governing trees on both public and private property. He supervises four urban foresters and others on his staff. Prior to his appointment as Urban Forest Manager in 2018, he worked as a County urban forester for seven years. He is a certified arborist, graduated from Ohio State University with a major in GIS mapping and a minor in natural resources management, and then received a master's degree from Virginia Tech in natural resources management and policy. Vincent's team's duties include tree care, plans, reviewing developers' tree canopy protection for trees during construction, designating heritage and specimen trees, and helping implement the lot coverage and other aspects of the Forestry and Natural Resources Plan adopted by the County Board last December.

The Current is distributed free of charge to all households in the Donaldson Run Civic Association (DRCA) area. DRCA, like all civic associations in Arlington, is a neighborhood administered organization, by elected volunteers. The DRCA promotes information sharing and discussion on neighborhood, local, and regional issues. DRCA boundaries are: Military Road on the east (including Marcey Road, North 26th Street, North 25th Place, and North Ridgeview Road); 26th/31st Street on the north; Lorcom Lane on the south (including North Randolph Street and 27th Streets south of Lorcom Lane); and Vernon Street on the west.

### JUNE 12 DRCA MEETING TO ELECT OFFICERS AND DIRECTORS FOR NEXT TWO-YEAR TERM Charlie Henkin

Every two years the terms of all nine Donaldson Run Civic Association (DRCA) officers and directors expire. This year, the election for new officers and directors will be held at the civic association meeting on June 12. Consistent with Article V of the DRCA Constitution, a nominating committee consisting of Charlie Henkin, Amanda Weaver and John Fisher was established to fill these nine positions following requests for interested DRCA members.

All but two of the current DRCA board members have consented to serve an additional two-year term. The first of these two positions is for a director to replace Susan Cunningham, who resigned upon her election to the Arlington County Board (congratulations, Susan). The nominating committee's proposed candidate for this position is Laura Yoeckel-Kelly. Laura has lived in the neighborhood since 2004. She is a VP at Booz, Allen with extensive credentials in business as well as volunteer work. She has a BA from Trinity University and an MS from Virginia Tech.

The second of these two positions is Secretary, following Jen Mehmood's decision to step down. (Many thanks, Jen, for all your hard work, particularly in connection with the successful introduction of our ice cream socials.) The nominating committee's candidate for this position is Dana Miller, who has been serving in the interim position of EC Director to fill out Susan Cunningham's current term. Dana grew up in Bellevue Forest and graduated from Yorktown High School. She has a BS cum laude from the University of Tampa, where she held student leadership positions. She has consulting, HR, and administration experience as well as volunteer work following graduation in 2012. She is currently Manager and Assistant Brewer of a local brewery.

With these two candidates for the vacant slots, the nominating committee is proposing the following slate for election at the meeting in June:

## MISSING MIDDLE CHANGE SPARKS RESTRICTIVE COVENANT LITIGATION

The current owner of the former Broyhill property (on the hill overlooking the intersection of Vermont and 26th Streets) has indicated an interest in possibly using the property to build multifamily homes, pursuant to the missing middle amendments to the Zoning Ordinance that became effective last July. The property, however, is subject to a 1947 restrictive covenant governing a number of homes in that area, which limits use of these lots to single-family homes. The owner has filed an action against ten neighbors in Arlington Circuit Court, seeking a declaratory judgment that this restrictive covenant is not enforceable. Among other things, the owner argues that the covenant no longer runs with the land because it was breached by several prior subdivisions of the property. (The restrictive covenant among these neighboring homes also limits subdivision.) The owner argues that the single-family home restriction has been waived, abandoned, or otherwise lost through acquiescence in the separate subdivision restriction of the covenant. The case is currently scheduled to go to trial before the judge in September.

### STATUS OF "MISSING MIDDLE" ZONING CHANGE Bill Richardson

In a controversial decision effective in July 2023, the County Board amended the Zoning Ordinance to permit construction of multifamily dwellings in all single-family residential districts, including those in DRCA. These "missing middle" - or "Expanded Housing Option" (EHO) – permits are limited to 58 each calendar year, to be spread out among a maximum of 37 in districts with smaller lots and 21 in districts (like most of DRCA) with larger lots. The Board permits EHOs of up to six units per structure. Applicants must first obtain approval from staff that they have complied with the various requirements for EHOs, and then must also submit a building permit application as with other projects. As of March, according to County staff, 48 such EHO applications had been submitted, with 30 approved. Only three of these 48 applications so far are for projects in larger lot districts (R-8, R-10, and R-20, referring to the number of thousands of square feet required for the lot).

Only one EHO application has been filed in DRCA, in April 2024, for a project on Vermont Street several blocks north of Langston Boulevard. The three townhouse units proposed here would each have three stories above a garage. The project will cover 39.2 percent of the oversized (10,241 square feet) R-8 lot, making almost full use of the extra five percent lot coverage now permitted for EHO, as compared to only 35 percent permitted for single-family homes in R-8 districts. It would be 36.3 feet in height, based on County rules (1) calculating the 35-foot cap for certain roof designs by reducing the roof height by one-half, and (2) averaging elevation points (significant on such a hillside property). The plan calls for elimination of at least a dozen trees on the lot, including those of 31, 24, 18, 17, and 12 inches in diameter.

DRCA was actively involved in meetings with County Board members leading up to the adoption of the EHO zoning amendments, working together with about a dozen other civic associations. These civic associations unsuccessfully tried to persuade Board members that such substantial revision of the Zoning Ordinance should have been preceded by an analysis of such issues as (1) whether EHO units would be likely to reduce the price of homes (or conversely to lead to teardowns of smaller homes replaced by expensive ones), (2) what their infrastructure (stormwater, schools, traffic, etc.) impacts would be and who would pay for such impacts, (3) whether state law would reduce by up to 50 percent the tree canopy requirements for EHOs otherwise applicable to single-family homes, and (4) whether EHOs should be permitted without first reforming the foregoing lot coverage and height limits (for single-family as well as EHO homes). These associations also argued that, since the County had predicted only 19 to 21 EHOs each year, it should cap them at that range for now, rather than at 58 each year.

Last year, ten Arlington residents challenged the EHO ordinance in Arlington County Circuit Court, alleging the County had violated procedural and substantive zoning requirements under state law. The County sought to dismiss their challenge on the merits, as well as their standing to bring it, seeking to avoid the need for a trial of the claims. The court has denied these efforts by the County, and trial is now scheduled to begin in July.

This lawsuit, brought against Arlington County, is different from a separate one pending between the owner of the former Broyhill property and its DRCA neighbors as described on page 3 of this newsletter.

### LOT COVERAGE STUDY FUNDED IN COUNTY'S FY 2025 BUDGET Bill Richardson

For many years, DRCA has requested that the County make good on staff's recognition in the 2014 Stormwater Master Plan of a need to take another look at the generous lot coverage (and height and setback) limits for residential construction. Our repeated filings with the County Board, posted on our website at www.drca.org, have noted the accelerated effects of teardowns in mature trees, contributing destroying to stormwater management problems in light of the increased frequency and severity of rainstorms, and destroying the viewsheds of neighboring These teardowns have also led to homes. reduction in the number of smaller, less expensive homes to make way for larger ones. After the County proposed to extend the current lot coverage and height limits to "missing middle" homes, a number of civic associations and others urged the County not to move forward with the

missing middle proposal until first addressing this long recognized problem – posed by both single family and multifamily homes.

After the County Board declined that invitation in adopting its missing middle proposal, DRCA and twelve other civic associations continued to press for a study of these issues to determine whether to propose reforms to the Zoning Ordinance to address them. The Forestry and Natural Resources Commission did so too, in comments urging prompt implementation of the draft Forestry and Natural Resources Plan calling for such a study. The Board adopted that Plan last December. Tree advocates and two former members of the Planning Commission have also urged the County Board to consider a new framework for addressing these issues of "bulk" residential structures.

At a March budget work session with County staff, County Board members expressed disappointment with the staff's failure to initiate such a study despite prior assurances. In adopting the budget in April, the County Board issued a directive to begin such a study, reinstating a proposed deletion of a planner position in order to provide funding to do so. In recent follow-up conversations with County Board members, DRCA and others continue to urge them to make good as soon as possible on the Forestry and Natural Resources Plan commitment to review these zoning issues. The continuing and irreparable damage suffered by our neighborhoods from neglecting them over the course of the last decade or more requires prompt action, if we are to achieve the County's 40 percent tree canopy goal.
