I am writing this on the first school day after the Labor Day weekend. Although the number of civic meetings was decidedly reduced during the summer, it was still an active time. The County sponsored three meetings regarding the relocation of Fire Station 8, and a final meeting is scheduled in mid-September

(http://projects.arlingtonva.us/projects/fire-station-8/). Since parts of Donaldson Run are served by this fire station, and the County's preferred location is close to an entrance to our neighborhood, this is an important topic for our neighborhood.

Two other items that received a lot of Donaldson Run Civic Association attention this summer were the proposed farmers' market at Marymount and the Stratford school addition. A use permit for the Farmer's market has been filed with the County. If approved, the market is planned to begin next spring. It will be located in a parking lot on the front of the Marymount campus on Glebe Road. Patrons of the market will park in the parking garage next to the library.

A lot of effort has been put forth this summer to develop a successful addition at Stratford School.

Balancing the interests of the neighbors, commuters, users. environmentalists, and advocates, while planning a school that meets the needs of the students, has been a Herculean task. Several concept schemes are under consideration, as well as an Old Dominion Drive vehicle access to the school, which received unanimous support at a DRCA meeting last November. The design options are significantly over budget, and a lot of work needs to be done to reach the best design choice that is financially feasible. I hope that you will come to our October 7 meeting to get the latest information about the new middle school that will serve our neighborhood. A big thank you to DRCA resident Susan Cunningham, who has spent countless hours working on this issue as the Chair of the Building Level Planning Committee for Stratford.

Our fall meeting will be on October 7 at Taylor School. In addition to the Stratford update, we will hear about alternative transportation modes including a new initiative with cars2go. County Board member Libby Garvey also will join us as part of her listening tour around the County. This will be a great opportunity to let a board member know what Arlington issues are on your mind.

Also coming up this fall will be a community-wide charrette focusing on the future of Lee Highway. We are all invited to provide input as efforts are made to envision what we (residents and businesses) would like to see along this important corridor. The County plans to host the charrette sometime between late October and mid-November. We will email the details to you when we receive them. VACATION LANE PEDESTRIAN PROJECT PROGRESSING

Arlington County's Department of Community Planning, Housing and Development is making progress on the pedestrian safety and street improvement project on Vacation Lane, a project which was approved by the DRCA in 2013. The project includes installation of curb extensions at the intersection of Vacation Lane at Utah Street and at Stuart Street. It also will replace the current substandard sidewalk with a 7′ sidewalk on the west side of Utah Street up to the driveway apron at 4400 Vacation Lane. A stop sign will replace the existing yield sign at the corner of Stuart Street and parking will be removed within that intersection.

The County anticipates the 60 percent design plan to be completed by spring 2016, followed by a final design review meeting with the neighborhood. This meeting will give property owners a final opportunity before construction to ensure that the project has been designed as scoped and funded. At the meeting, comments, questions, and concerns will be addressed, and it may be necessary for the County engineer to update the final design. In addition, Temporary Easements and Construction Agreements (TECA) which are obtained before construction begins, will be discussed at the final design meeting, followed by a pre-construction meeting internally and with the property owners. Based on the 29-month implementation process, construction and final walk-through should be completed by March 2017.

AIRPLANE NOISE FROM REAGAN NATIONAL AIRPORT (DCA) TRAFFIC

A longstanding issue for North Arlington residents has been the noise from airplane traffic into and out of DCA. Over the years, FAA mandates for quieter engines on commercial aircraft have been effective in reducing the noise from individual commercial airline flights. But the increase in flights of larger aircraft and jet vs. prop aircraft at DCA in recent years, the absence of any ban at all on flights using quieter engines between 10 PM and 7 AM, and economics behind carriers employing these hours has contributed to growing objections to noise from this valued local transportation hub.

These issues were aired in a June 18 meeting sponsored by Libby Garvey for the Arlington Board and attended by about 100 other county citizens, the Federal Aviation Administration (FAA) and the Metropolitan Washington Airport Authority (MWAA). Ms. Garvey noted Arlington is hardly alone in a broader regional and national trend objecting to such noise. Ms. Garvey is the County Board member on point for this issue, and will attend our 7 October DRCA meeting.

Since the June 18 meeting, Ms. Garvey has forwarded the following on steps taken by the county:

1. Árlington officially joined N.O.I.S.E. (The National Organization to Insure a Sound Controlled Environment), the preeminent advocacy organization for local communities across the country that experience aviation noise and an affiliate of the National League of Cities. More information on N.O.I.S.E. can be found on their webpagehttps://www.aviation-noise.org/>.

N.O.I.S.E. will provide Arlington County with technical expertise in the area of aviation noise and provide the opportunity for the County to coordinate nationally with other jurisdictions that are impacted by aviation noise.

2. The Board has gathered questions from Arlington residents and sent them to the FAA and MWAA for response. A copy of the letter can be found on the County's aviation noise webpage http://departments.arlingtonva.us/cmo/airportnoise/>.

Some of the questions raised at the June 18 meeting illuminate the perhaps arcane or technical issues and include:

- There is a procedure for flying over the Potomac River upon departure, rather than over land, using a more precise satellite-based navigation system (called LAZIR) which reduces the noise over Arlington. The process for introducing more LAZIR use depends crucially on commercial carriers modernizing their navigation systems to benefit from LAZIR (at DCA and indeed other airports.) The LAZIR issue includes:
- --to what degree the FAA can incentivize carriers to adopt LAZIR equipment
- --what timelines for adoption the FAA foresees as feasible, and
- --why should not LAZIR or some other "over water" procedure be adopted for arriving flights as well as departing flights?
- Why can't there be restrictions on all flights (exempting cases of emergency requiring a landing at DCA) between 10 PM and 7 AM, not just those flights in compliance with noise reduction technology?
- The MD-80 is the noisiest aircraft that is compliant with the noise reduction standard. American and Delta Airlines have been asked to remove this aircraft from operations at DCA, but the decision is up to those airlines. Why must this be the case?
- Do we believe the Metropolitan Washington Airport Authority (MWAA) demand that no additional flight slots be permitted will be sustained in the face of increasing passenger demand and Congressional support for DCA service?
- 3. The Board has received a letter from Mr. Jack Potter, the President and CEO MWAA, informing the County Board of its establishment of a Reagan National Airport Community Working Group, which will be tasked with identifying and recommending practical noise mitigation initiatives to the FAA by the Summer of 2016. The Working Group will be comprised of two community representatives each from Arlington County, Wards 2,3, 6,7, and 8 in the District of Columbia, the City of Alexandria, and the Dranesville and Mount Vernon Supervisor Districts of Fairfax County. The Arlington County Board will select the two Arlington County representatives to serve on the Working Group.
- 4. Ms. Garvey has met with staff from Senator Kaine's office and plans to meet with the CEO of MWAA, Jack Potter, soon to strengthen our working relationship on airport noise issues.
- 5. She has also begun discussions with some of her regional counterparts about setting up a standing committee of elected officials concerned about airport issues so that we can begin to follow and address these issues from a regional perspective.

DONALDSON RUN TRIBUTARY B RESTORATION UPDATE

Since 2001, the Donaldson Run Civic Association (DRCA) has been a partner for the Donaldson Run stream restoration projects. DRCA has committed Neighborhood Conservation Program funding, as well as provided input on the design plans. When Donaldson Run's Tributary A restoration project was completed in 2006, it was known at that time that Tributary B was also an ideal restoration candidate. After several years of planning, we are nearing the construction phase for Tributary B. The restoration will span from N. Upton St to where Tributary B meets the restored Tributary A in Zachary Taylor Park. The project length is approximately 1,500 linear feet, or three tenths of a mile, and is half the length of the Tributary A project. The natural stream channel design method will be applied to Tributary B, as it was to Tributary A. The restoration of Tributary B will:

- · Protect existing infrastructure the water main and sanitary sewer and laterals
- Remove invasive plants within the project area. The area will be replanted with native plants.
- · Protect the existing trail from erosion
- · Improve water quality for Donaldson Run, the Potomac River, and the Chesapeake Bay by addressing erosion (thus reducing sediment and nutrient pollution).

In the spring of 2015, the County received the necessary property easements along Tributary B and submitted the construction permit request to the Army Corps of Engineers. The restoration design plans for Tributary B are nearing the final stages. Currently designers are planning elements of the construction logistics, such as construction entrances, staging and storage areas, and protection of the existing resources. The County will give an update to the Donaldson Run Civic Association in the Spring of 2016 that will include an additional opportunity to see and provide input on the restoration and planting plans. Native plant species that have been successful with Tributary A's restoration, and other native species found in Zachary Taylor Park, will comprise the planting plan. Construction bid documents are scheduled to be prepared for Tributary B in 2016. The County's remaining "to-do list" for Tributary B includes:

- · Address remaining infrastructure design elements and develop planting plan for Tributary B;
- · Presentation to citizens of Donaldson Run;
- · Finalize design and planting plans;
- · Complete technical specifications for construction bid documents;
- · Obtain necessary permits;

- · Accept construction bids;
- · Bid awarded by County Board;
- · Project goes to construction;

STOP FOR SCHOOL BUSES

School buses in Arlington now carry cameras to automatically catch drivers who fail to stop when required while the school bus is picking up or discharging passengers. A ticket for failing to obey the school bus law is a misdemeanor and carries a fine, six points on the offending driver's license, and even possible jail time.

Here are the rules quoted from the Virginia Driver's Manual:

"You must stop for stopped school buses with flashing red lights and an extended stop sign when you approach from any direction on a highway, private road or school driveway. Stop and remain stopped until all persons are clear and the bus moves again.

"You must also stop if the bus is loading or unloading passengers and the signals are not on.
"You do not have to stop if you are traveling in the

"You do not have to stop if you are traveling in the opposite direction on a roadway with a median or barrier dividing the road and the bus is on the opposite side of the median or barrier. However, be prepared for unexpected actions by persons exiting the school bus."

Note that the law requires drivers to stop when approaching from any direction. This includes cross traffic at an intersection when the school bus is 90 degrees to the direction of travel of the cross traffic. It also includes traffic that is on the opposite side of a painted median that does not provide a physical barrier.

Now that school is in session, please be especially careful and look out for children using the roadways.

There is nothing better on a beautiful fall day than to walk your dog in the park. Great exercise for you; great exercise for your pup. In fact, numerous studies show that dogs can improve human health. Arlington has a variety of opportunities for you to be active with your dog. With eight parks designated as dog parks and more than a hundred human/dog parks to choose from, there really isn't any excuse not to get out.

County dog parks are the only places in Arlington where a dog does not have to be on leash. Dogs are never allowed off leash in parks or neighborhoods. You can take your pooch (on leash) pretty much anywhere except playgrounds. As much as many children love dogs and vice versa, it is not

wise to have them play together on a playground. Both breeds (human and dog) could behave in a manner that causes harm to the other and consequently, Arlington prohibits dogs in playgrounds, even if they are on leash.

A number of County parks have streams, and as much as your pooch may enjoy it, it is important to remember that Arlington streams receive untreated stormwater runoff from the County's streets. Stormwater washes petroleum, bacteria and other

pathogens, dirt, and litter into our streams. Bacteria and pathogens are not visible to our eye and may be present even when the water is clear. Data from the County's volunteer bacteria monitoring program can be found at

http://environment.arlingtonva.us/streams/stream-monitoring/. Broken glass, wire, and sharp metal also are often found along the stream bottom and cannot be easily seen. Keep these risks in mind before allowing your dog to play in our streams.

Go to parks.arlingtonva.us to find out about nearby dog parks where you and your pooch can run free and meet other two- and four-legged creatures. The website also lists parks and background information on dog health.
