ceremony, Susan takes her cue in that regard from Frances Perkins, the first female U.S. cabinet secretary, appointed by FDR following his prior appointment of her as a leading expert on occupational safety during his tenure as Governor of New York. Perkins was taught to "Go where no one else will go, do what no one else will do." Susan is well equipped to do just that.

Speaking of public service, DRCA continues to need volunteers in two areas. Please let me know if either of these interests you.

First, we need to fill Susan's position as a DRCA board member, as well as other anticipated vacancies. Signing up for a two-year term on DRCA's board requires little more than attendance at periodic board meetings, and volunteering to follow as many or as few projects or issues as time permits for you, including our periodic social events. It is a great way to learn what is going on in or affecting our neighborhood, in real time.

Second, as previously noted, we are updating our 2000 Neighborhood Conservation Plan to reflect the summary our board member Amanda Weaver has prepared of the over 200 responses you provided to our survey questionnaire last year concerning issues affecting DRCA. This will enable us to document for County staff your latest views as they may affect County proposals that affect our neighborhood. We need drafters to help us with this update, which we have divided into various sections of the current plan relating to such topics as County facilities in DRCA, neighborhood traffic, nearby parks and recreation areas, and the need for changes to sidewalks, curbs/gutters, street lights, and signage. ## 23<sup>rd</sup> STREET SIDEWALK PROJECT MOVING FORWARD

Given the larger student body and student walkers associated with the establishment of Dorothy Hamm Middle School (DHMS), several years ago residents of 23rd Street proposed a sidewalk from Lorcom Lane down the hill to Vacation Lane. This proposal was made within the Arlington Neighborhoods Program (ANP, formerly the

Neighborhood Conservation Program). The sidewalk project has moved up in priority over the years and progress has been made in recent months.

A neighborhood block captain has been named; this resident has begun a "clipboard survey" of households contiguous to where the sidewalk would be installed. The ANP program requires that 60 percent of these homeowners approve of the project for it to go forward. Should that happen, the timeline then calls for a site survey, conceptual design, an on-site meeting with neighbors, final petition, and finally funding. Right now, this project is expected to be funded this June though that could slip to December. Once funded, projects usually take between 1-2 years to progress to construction and most projects' construction around year. # UPDATE ON "MISSING MIDDLE" (AKA "EHO")

As you may recall, last year the County eliminated the single-family only provisions of the Zoning Ordinance, to permit construction of up to six multifamily homes in each residential district, including DRCA. DRCA had expressed concerns about taking this action without first (1) conducting an assessment of the proposal's benefits (e.g., whether the resulting homes would still be very expensive and whether they would include 3 BR homes of the kind that are in greater shortage) and costs (schools, traffic, stormwater management, etc.) and (2) reforming the lot coverage provisions of the ordinance, which DRCA has for many years pointed out permit too large an impervious footprint, and which will be extended now to apply to multi-family homes as

Last year, a group of ten Arlington homeowners filed a lawsuit in Arlington Circuit Court, challenging this new "EHO" ordinance. In November, Judge Schell denied the County's effort to throw out the case without having to go to trial. In January of this year, he further denied the County's effort to appeal (prior to trial) his ruling that the plaintiffs had standing to bring such a case based on their claims of particularized injury.

This means that as of now the case will proceed to a trial on the homeowner claims, beginning on July 8. We expect the case will focus, among other things, on the adequacy of the County's notice of the contours of its new rules and of its claims about their benefits and costs, and the deference to which it may be entitled for these claims in court.

A court challenge to Alexandria's version of this zoning change has more recently been filed in Alexandria Circuit Court. It appears from newspaper accounts to raise similar issues.

According to information compiled by Arlingtonians for our Sustainable Future (which opposed EHO), the status of EHO applications in Arlington since the ordinance has become effective is as follows:

■ Although the County had predicted only 19-21 lots would be redeveloped as EHO each year, in the first six months it received 50 EHO applications. (It is unclear whether this number would have been greater in the absence of the pending litigation.)

- Of the 26 of these approved so far, 11 are 6-plexes, 2 are 4-plexes, 8 are 3-unit townhouses, and five are 2-unit structures.
- All of these 26 are in R-5 and R-6 zones. Only one of the remaining applications still pending is for redevelopment in a larger lot zone (R-10).

## INCREASE IN ARLINGTON PROPERTY TAX VALUES FOR 2024

The County has recently reported that residential property values increased 3.2 percent in 2024. The average single-family property value increased from \$798,500 to \$824,700. If you have not received your 2024 assessment, you can find it at https://propertysearch.arlingtonva.us/.

While commercial property values increased by 1.6 percent, this increase is the result of significant investment, principally in the Crystal City area. Existing office values decreased by 11 percent due to continued pressure of office vacancy rates. In light of this trend, residential property now provides 55 percent of the County's real estate tax base. The County notes that this factor, along with cost increases, wage growth, and higher interest rates, poses challenges for the upcoming FY 2025 budget.

## MORE LONG DISTANCE FLIGHTS AT REAGAN NATIONAL AIRPORT

The Federal Aviation Administration receives authorization from Congress every five years. This year (beginning in FY 2024) is one such year. Typically the Senate or House will entertain advocacy for more flights to be allowed that exceed the 1250 mile "perimeter" established to constrain the amount of long distance flights into Reagan National Airport (DCA). The existing limit on such flights supports use of Dulles Airport (IAD) for such flights, which has more runways and greater support capability in storms and recently added direct Metro service. It is noteworthy that in the recent (January 15 and later) snow storm DCA experienced more flight cancellations than any major US airport.

In June, DRCA wrote to strongly oppose House Commerce Committee consideration of more exemptions from the perimeter constraint. The House committee decided against more exemptions. In January, DRCA wrote a similar letter to the Senate Commerce Committee drafting their authorization bill. Both letters are available on our website at www.drca.org. The Senate committee has not finalized their authorization bill, but public reporting indicates that Sen. Cantwell and Sen. Cruz, the committee chair and ranking member, are seeking an allowance for two more long distance slots at DCA. Both senators are from States beyond the perimeter.

Congress is hoping to pass this needed reauthorization legislation for the FAA by the March 1 date of the expiration of FAA's current authorization. You can express your views on this matter to Rep. Don Beyer and Senators Kaine and Warner, all of whom have opposed the expansion of long distance flights for DCA.

# DRCA'S INPUT INTO PICKLEBALL STRIPING AT MARCEY PARK TENNIS COURTS

The DRCA Executive Committee has been very involved in the Department of Parks and Recreation's (DPR) Countywide program during the past year to stripe existing tennis courts for pickleball. We have approached this issue with a

focus on the traffic and parking strains that already exist at the popular and co-located Marcey Road Park and Potomac Overlook Park. We have refrained from taking a position as to whether the courts should be striped for pickleball.

Last summer, we joined the Arlington County Tennis Association (ACTA) in an initial meeting with County Manager Mark Schwartz. We outlined our concerns that the influx of pickleball players to the park (as many as twenty players on the three courts rather than the current maximum of twelve) could exacerbate the problems of traffic on Marcey Road during busy times as well as limited parking. The Manager committed to check with Transportation staff about how pickleball would affect the traffic and parking on Marcey Road. We still await his response. As a follow-up, last fall we met with DPR Director Jane Rudolph and were joined by a neighbor residing on Marcey Road. At this meeting, the problem of noise pickleball paddles generated by was discussed.

The County has responded to our concerns by installing noise abatement fencing around part of the Marcey Road tennis courts as a means of limiting noise pollution caused by pickleball. We will continue to press the County for a response on our traffic/parking concerns and would welcome input from DRCA residents on how to mitigate these issues.

# THE MAGIC OF WINTER TREES

Winter is a lovely time to get to know your trees better. Many folks spend some of the colder days of January and February planning their spring gardens, winter sowing, or putting in nursery orders for spring delivery of native plants. Dreams of warmer days are lovely, but if you have trees in your yard or a nearby park, winter might also be the time to learn how to appreciate and protect their incredible beauty.

When our trees are bare of leaves, you can visualize more clearly their beautiful shapes, identify some species characteristics and assess their health status. There are several local organizations that provide winter educational hikes or webinars to examine and learn about our forests, including Nature Forward, Virginia Native Plant Society – Potowmack Chapter, Capital Nature, Loudoun Wildlife Conservancy, Audubon Society of Northern Virginia, and others.

For those that love to undertake vigorous outdoor work in the winter, now is the time to protect our trees by starting to pull, dig, or hack and squirt the invasives in your yard or to volunteer for similar ongoing activities in your community. With the exception of a few native evergreens, almost all the large swaths of green you see in your neighborhood and along the roads are invasive, non-native plants—from Wintergreen to Vinca, to English Ivy, from Privet to non-native Holly species, to Bamboo. You can find organizations volunteer opportunities with www.plantnovanatives.org. Invasive plants displace the tree seedlings that are essential for our future forests, and some of them directly kill the larger trees.

So, if you want to learn about trees, to more closely observe nature, to find quiet time for spiritual reflection, or to vigorously get rid of tree enemies, winter is a magical time to spend outside in the stillness and beauty of the forest.

Plant NOVA Natives is the joint outreach campaign of a grand coalition of non-profit, governmental, and private groups, plus hundreds of individuals, all working to reverse the decline of native plants and wildlife in Northern Virginia. Our strategy is to encourage residents as well as public and commercial entities to install native plants as the first step toward creating wildlife habitat and functioning ecosystems on their own properties. All are welcome to participate in this collective action movement!
